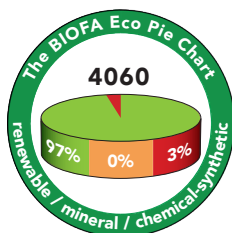

## Properties:

## Ingredients:

Water, citric acid, <5% anionic and amphoteric surfactant from coconut fat, formic acid, ethanol, polysaccharide / starch, lavender oil, peppermint oil, colorants, silver sulfate.



## Application:

Using a nozzle, spray on the surface to be cleaned, making sure to get in niches and under pool edges, etc. Use a brush or a sponge to distribute. Allow to take effect and then thoroughly rinse off. To avoid staining chromed surfaces, the treated surface may be dry-polished.

## Storage:

Keep cool, protect against frost, and store properly sealed.

## Container:

1 l PE/PP Plastic bottle  
5 l PE/PP Plastic canister



## Disposal:

Use up product completely whenever possible. Dispose liquid product leftovers and partially full and cleaned containers in compliance with local statutory regulations.
